#### ORDER:-

The Director General of Foreign Trade, Ministry of Commerce and Industry, Government of India, New Delhi in their Notification first read above has accorded permission to the State Government of Andhra Pradesh to export 8,584.1363 MTs. of Red Sanders Wood in log form out of confiscated/seized stock available with the State Government either by itself or through any entity/entities so authorized by the Government and the whole process of export shall be completed latest by 30<sup>th</sup> April, 2019.

2. In the G.O. second read above, the Government have constituted a Tender Committee under the Chairmanship of Principal Secretary to Government, EFS&T Department to work out the modalities for conducting sale of Red Sanders Wood in log form through Global e-Tender cum e-Auction.

3. The Government, after careful examination of the proposal of the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd. in the letter 3<sup>rd</sup> read above, hereby order on the recommendations of the Tender Committee as summarized below:-

- a. Accept the Special Terms and Conditions for conducting global e-tender-cum-eauction proposed by the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd.
- b. Authorise the Andhra Pradesh Forest Development Corporation Limited to engage the services of M/s MSTC Ltd. for conducting the sale of Red Sanders Wood through global e-tender cum e-auction on the terms and conditions approved by the Government in ITE & C (eprocurement) Department vide G.O. Rt. No. 47, Dated.5-7-2017.
- c. Direct the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd. to issue tender notification in reputed International and National publications and specialized journals targeting the potential buyers, across the World especially in the China in the local languages as Government orders for sale of red Sanders Wood of about 965.494 MTs. in log form through e-tender-cum-e-auction by inviting global tenders through transparent and competitive process.

d. Direct the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd. to circulate copies of the tender notification to the Ministry of External Affairs (MEA) and all ambassadors and foreign Missions especially that of China, Japan, Malaysia, Singapore, UAE, Thailand and Indonesia and Indian embassies in China, Japan, Malaysia, Singapore, UAE, Thailand and Indonesia etc.

- e. Authorize the Tender Committee to make any improvements in the process of sale that would maximize returns to the State.
- f. To conduct Red Sanders Wood sales from 10.00 AM to 2.00 PM of IST in three cycles, two days in each cycle with 5 days gap /interval. The first cycle shall be on 24.01.2018 & 27.01.2018. The unsold Red Sanders Wood if any, in the first cycle would be put for sale on 29.01.2018 & 31.01.2018 in the Second cycle an would be put for sale 02.02.2018 & 05.02.2018 in third cycle of sale.
- g. Constitute an "Auction Team" to co-ordinate the auction process and to take the steps to notify the lots which will fetch more revenue to the Department in the Phase-IX of global tender of the Red Sanders Wood with the following officers:
  - i) Principal Chief Conservator of Forests (Prod.) as Chairman
  - ii) Chief Conservator of Forests, Kurnool as Member
  - iii) Chief General Manager, APFDC as Member Convener

4. The Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, / Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd., shall take further necessary action in the matter accordingly.
