Global Notice for sale of Red Sanders (Pterocarpus santalinus) Wood

1. Red Sanders (*Pterocarpus santalinus*) is a highly valuable hard-wood species that is exclusively found in the Forests located in Andhra Pradesh State of India. Red Sanders Wood (RSW) referred to in China as Zitan (嫦 is used for making exclusive and classical hardwood furniture. The State Government of Andhra Pradesh has monopoly and absolute rights over the management, possession and sale of Red Sanders Wood.

The Government of Andhra Pradesh (GOAP) has authorized its corporate subsidiary, Andhra Pradesh Forest Development Corporation Limited (APFDC), a wholly owned Government of Andhra Pradesh Enterprise, in its orders No. G.O. Rt. No.43 of EFS&T (Sec. II) Department, dated 27.3.2018 and G.O. Rt. No.45 of EFS&T (Sec. II) Department, dated 29.3.2018 to conduct the sale of Red Sanders Wood (RSW) currently in its possession. Accordingly, APFDC hereby notifies the sale of **1363.53 MTs** of dressed and graded Red sanders wood (RSW) in the log form on 'as-is-where-is' basis stored at the **State of the Art godown at Tirupati** Chittoor District, Andhra Pradesh state, India.

The Director General of Foreign Trade (DGFT), Government of India through Notification No.47 (RE-2013)/2009-2014 Dated.24.10.2013, Notification No.96 (R.E-2013)/2009-2014, Dated.5.11.2014, Notification No. 6 /2015-2020, Dated. 6-5-2015, Notification No. 24 /2015-2020, Dt. 29-8-2016 and Notification No. 8 /2015-2020, Dt. 23.5.2017, has permitted the export of Red Sanders Wood in the form of logs.
