In respect of S.no.14 sawmill of M/s Khaja Khajar Sawmill, proposed to relocate from Guntur to Vizianagaram within a distance of 5.05 km from the nearest forest, the Divisional Forest Officer, Vizianagaram is requested to reverify the distance from the nearest forest boundary before issuing orders for relocation of sawmill in Vizianagaram Division.

The DFOs are informed that the SLC gives in-principle approvals for various proposals. The DFOs must ensure that all the requirements are met and statutory approvals are obtained from the Line Departments by the sawmill owners for establishing the sawmill on relocation in the proposed site.

4 Fresh license for lapsed licenses

The (2)proposals for issue of fresh license for lapsed licenses placed before the SLC, have been examined by the members of the Committee and agreed to the proposal under Rule 10 (2) since the Circle Head and Divisional Forest Officers have recommended for the same as they fulfill the conditions stipulated in the rules.

5. OTHER ITEMS:

Sri Dwara Ramakrishna, General Secretary, Andhra Pradesh Federation of Timber Merchants, Sawmillers & Allied Industries has proposed for permitting the sawmill owners to file nominee details with the Licensing Authority, so that in the event of demise of the sawmill owner, the operation of the sawmill does not get affected, till the time the transfer of ownership to the legal heir is completed.

In this regard, the SLC after discussion and deliberations, agreed that this may be permitted in line with the 'Ease of Doing Business' (EoDB), provided the Sawmill owner produces a registered document declaring that in the event of his demise, the nominee will run the sawmill till such time the ownership is transferred in favour of the legal heir.

The meeting concluded with the Addl. Prl. Chief Conservator of Forests (Production) and Member Secretary thanking all the members for participating and providing their valuable inputs.
