1. Action Taken Report of the 8th SLC meeting:

2. Sub-committee Report on lapsed sawmill licenses:

The Addl.PCCF (Prodn.) informed that a sub-committee was constituted in 8^{th} SLC to examine the saw mills whose licenses had lapsed and submit its report to SLC to take further call. The sub-committee had met on 30^{th} June, 2020 and accordingly its report was placed before the SLC for further course of action.

The SLC after considering the sub-committee report, deliberated upon all the cases and accordingly following decisions were taken on the lapsed sawmill licenses placed before the SLC.

5. Lapsed Saw Mill licenses:

7. Case of (56) Saw Mills established post 30.10.2002:

A presentation was made to the members regarding the background of old (56) Saw Mills on the following lines:

- SC order dated 30.10.2002, provided that "No license for a saw mill can be granted without obtaining prior permission from the CEC."
- However, 306 saw mills were granted licenses by the APFD post 30.10.2002 and subsequently cancelled by the APFD when it was found to be in violation of the SC order.
- (50)saw mill owners aggrieved by above action of the APFD filed IAs in SC.
- SC in its'order dated 25-10-2010 directed the Centrally Empowered Committee (CEC) to consider the applications filed by the Applicants before the CEC for grant of Saw Mill Licenses.
- CEC constituted State Level Committee (SLC) for AP to consider the above issue and recommend to CEC.
- The SLC in its meeting dated 14.09.2011 observed that there were actually (197) saw mills that were granted licenses post 30.10.2002 and subsequently cancelled by the deptt.
- Out of (197), (12) saw mills were found to be involved in some forest offences, leaving a balance of 185 saw mills which included (45) Applicants saw mills.
- The SLC in its report to GoAP vide Ref No. 36409/2011-V3 dt. 17.09.2011 recommended to seek orders from the SC as per decision of the CEC in its meeting on 10.12.2008 at New Delhi with the APFD officials.
- The GoAP in its letter 2239/For.III/2009 dated 17.10.2011 to CEC requested necessary permission for renewal of (185) saw mill licenses as recommended by the SLC.
- The CEC further submitted its report to SC dated 23.03.2012 for further orders.
- The CEC recommended to the SC that it may consider permitting renewal of saw mill licenses granted in favour of (185) saw mills including 45 Applicant saw mills as per the recommendations made by the SLC and

- GoAP in its letter dated 17.10.2011.
- Out of this (185), (56) saw mills pertain to the residuary state of AP post-bifurcation.
- CEC had recommended that <u>"in view of broad availability of raw material, these saw mills may be considered subject to one time payment of Rs10,000/- per vertical band saw and Rs 1.5 lakh per horizontal band saw, as has been done in Haryana, Punjab, UP and Uttrakhand.
 </u>
- Provided that the concerned saw mill is not found to be involved in any
 forest offence related to the use of illegal timber and /or timber
 transported without a valid transit pass. The saw mills involved in such
 forest offences will not be eligible for grant/renewal of saw mill licenses.
- And the saw mill is not located in an area where establishment/operation
 of the saw mill is prohibited under the AP Saw Mills Rules and/or under the
 notifications/guidelines issued by the competent authority.
- The Supreme Court in its order dated 05.10.2015 while disposing the IAs "authorised the SLC to take decisions regarding grant of license/permission to WBIs as per the guidelines to be issued by the MoEF in view of conformation with orders and directions issued by this court."
- As such, the matter has been pending with the SLC.

The members agreed that further decision can be taken to revive these saw mills in view of the recommendations of the CEC to the SC. As presented in the wood balance study, these saw mills require annually 50-60 thousand cum based on the calculations done as per Rule 7. The existing saw mills require maximum 20 lakh cum. The supply, as per the most conservative estimate, based on FSI estimation of Industrial round wood projections for AP in 2017 is 25 lakh cum. If it is fully ascertained how many of them really want to start the operations as it has been too long a period since licenses of these saw mills were cancelled by the FD in 2006, then estimate of the requirement of raw material for the saw mills willing to restart operations out of the (56) saw mills can be made and which would be less than 50 thousand cum. Therefore broadly raw material is available for these saw mills. As such sufficient supply exists for these saw mills. The SLC agreed to renew these licenses as recommended by the CEC and Hon'ble Supreme Court.

8. New saw mills /Additional capacity:

(13) applications for new licenses and (30) applications for sanction of Additional capacity in existing saw mills were received and placed before the SLC as given in following tables.

Further, it was brought before the SLC that (104) saw mills are using the additional Horizontal saws as per High Court orders.

The Hon'ble High Court of Andhra Pradesh in its orders dated 19.09.2018, analyzed the Andhra Pradesh Wood Based Industries (Establishment and Regulation) Rules, 2018 and felt that the State Level Committee constituted under the new Rules can dispose the grievance of petitioners, and disposed writ petitions in a batch of cases, with the following direction:

"In the circumstances, all these Writ Petitions are disposed of, granting liberty to the petitioners to submit their applications in Form-I to the Licensing Authority within four weeks from today. Thereupon, the Licensing Authority shall process the same within a period of three (3) months thereafter. Till such time, the petitioners shall be entitled to continue to run their wood based industries".

In view of foregoing discussion, proposals for the New sawmills, for Additional Machinery and proposals of all those saw mills which are operating additional horizontal saws on HC orders are deferred.

9. IWST, Bangalore study and Wood balance status in A.P:

A presentation was made to the SLC regarding IWST, Banglore wood balance study findings and recommendations:

- IWST was assigned the job of preparing the wood balance study in the state of AP through an Agreement between the APFD and IWST on 20.09.2017.
- The report was supposed to be submitted within (4) months time. However, the same has not been finalized till now and IWST asked for another (6) months time in February, 2020 to submit the final report.
- It is observed that IWST has not done any field inventory nor collected any Primary data.
- It has relied on APFD existing data as well as FSI, Dehradun statistics from the ISFR of 2017.
- No species-wise/district-wise exercise has been done.
- As such the report does not meet the Objectives for which it was taken up.

As can be seen, FSI source says at least 2.49 m cum material is available annually from the ToF plantations whereas the APFD study provides an estimate of about 3.5 m cum from the ToF plantations. In addition, the forests can supply0.20 m cum. So a very conservative estimate implies that 2.49+0.20= 2.69 m cum material is available broadly.

After discussions on all aspects, the SLC members agreed for the need to take up a holistic view and come up with district-wise and species-wise availability of the raw material as well as the demand of existing WBIs. For this the APFD ToF study conducted in 2010-14 may be finalized with a clear picture of wood availability.

10. Special items:

With the permission of the Chair, following (2) items were taken up by the SLC under this category:

(i) Streamlining the modalities for Registration of the WBIs that do not require license from the forest department as per Rule 8.

After detailed discussions, the SLC agreed that APFD may introduce an effective online Registration and Reporting process so as to ensure ease of doing business for such units as well ensure transparency in their functioning.

(ii) Setting up Imported Timber Processing Zone (ITPZ) in AP:

A brief presentation was made to the SLC on the need for setting up an ITPZ in Krishnapatnam or any other suitable port of AP on the lines of Gandhidham ITPZ in Kandla port. It holds 70% share of the India market. There are about 2000-2400 wood processing units and (84) Plywood units with annual turnover of Rs 30, 000 crores. It imports close to 4 million cubic meters of wood. It directly employs 35000 and indirectly employs 65000 persons. Even 6000 persons from AP also work there. As such, it was impressed upon to establish similar ITPZ in AP and tap the huge market potential. All the members found the idea very promising and agreed that the APFD may initiate further action in this regard, finalise the modalities with concerned departments and come up with the progress in next SLC.

The meeting concluded with the Prl.Chief Conservator of Forests & Head of Forest Force thanking all the members for participating and providing valuable inputs.
