In this regard, it is informed that the services of eligible DR Forest Range Officers of 2006 batch were regularized vide PCCFs Proc.No.16214/2009-A.1, dated 02-02-2012 as per Rules. Taking into consideration of said orders, their placement is assigned at appropriate place in the Provisional Seniority of Forest Range Officers as on 01-01-2012.

At present, panel year 2011-12 is in-force and determination of vacancies for the said panel year from all sources [i.e., due to retirement/death of DR / Promotees and Convertees / and promotion as Assistant Conservators of Forests etc.] will be done by the end of said panel year after asserting correct vacancy position. Thereafter, by taking into consideration of substantive vacancies and apportionment, the *ad hoc* promotees will be adjusted in the promotion quota vacancies that will arise during the said panel year by regularization of services of *ad hoc* promotees. Consequent to adjustment of ad hoc promotees in the promotion quota vacancies of 2011-12 panel year, their placements will be finalized in the next seniority list i.e., as on 01-01-2013.

In view of the above position and taking into consideration of substantive vacancies, the Provisional Seniority List of Forest Range Officers as on 01.01.2012 is prepared and send herewith for communicating to all Forest Range Officers under their control for information and also for inviting their objections if any, within a period of 30 days from the receipt of this letter.
