ORDER:

In the references 1st to 4th read above, orders were issued duly delegating financial powers on certain items of Forest Department to the Principal Chief Conservator of Forests, Regional Officers and District level Officers under the control of Principal Chief Conservator of Forests, Andhra Pradesh, Hyderabad.

2. The Principal Chief Conservator of Forests in his letter 5th read above has informed that the cost of all kinds have gone up due to which the existing powers are far minimum and requested to enhance the existing financial powers.

3. The Government after careful examination in the matter hereby fix the revised monetary ceiling limits of financial powers to be exercised by the Principal Chief Conservator of Forests, Andhra Pradesh, Hyderabad and Sub Ordinate Offices under his control as shown against each item in the Annexure enclosed to this order subject to the availability of budget provision.

4. This order issues with the concurrence of Finance and Planning (FW) Department vide their U.O. No.6253/42/A1/Admn.I-TFR/2000, dated 31-5-2000.
