## ORDER:

In the letters 3<sup>rd</sup> and 5<sup>th</sup> read above, the Principal Chief Conservator of Forests & HoFF, Andhra Pradesh has requested to consider the proposal of conferring Gazetted status to the posts of Managers /Superintendents working in the Forest Department duly re-designating them as Administrative Officer without increase in Pay Scale on par with other Departments.

- 2. In the U.O. Note 1<sup>st</sup> read above, certain instructions were issued that change in the status of Non-Gazetted post to a Gazetted post will not affect the reservation for local candidates and same should continue to be 70% in case of Direct recruitment to the zonal posts in such categories. In G.O. 2<sup>nd</sup> read above, orders were issued protecting the interests of the local candidates by retaining the original percentage of reservation in direct recruitment to these posts, in tune with the provisions of the Presidential Order and Government Order that the zonal character of these posts remain unchanged even after they are Gazetted.
- 3. Government after careful examination of the matter have decided to change the designation of Superintendents and Managers of Forest Department as Administrative Officer in the existing pay scale, duly conferring the Gazetted status, without any financial burden on the Government either now or in future.
- 4. The Principal Chief Conservator of Forests & HoFF, Andhra Pradesh, Mangalagiri shall take necessary action in the matter accordingly.
- 5. The Principal Chief Conservator of Forests & HoFF, Andhra Pradesh, Mangalagiri shall send necessary proposals for inclusion of the posts of Superintendents and Managers as Administrative Officer in 3<sup>rd</sup> schedule of the Presidential Order (Specified Gazetted category), 1975, stating the reason for such inclusion in detail for taking necessary action.

- 6. This order issues with the concurrence of Finance (PC-TA) Department vide their U.O.No.FIN-33027/13/2016-SO(HR IV)-FINANCE, dated 12.01.2023 (Computer No: 143162).
- 7. Accordingly, the following Notification will be published in the next issue of Andhra Pradesh Gazette:

## **NOTIFICATION**

"The designation of Superintendents and Managers working in Forest Department in the State shall be changed as Administrative Officer in the existing pay scale, duly conferring the Gazetted status, without any financial burden on the Government either now or in future with immediate effect".
