The Government after careful examination of the above proposals, hereby permit the Principal Chief Conservator of Forests to enhance the existing entry fee into the wildlife Sanctuaries and National Parks as mentioned in the Annexure – I. II & III to this G. O. Government also permits the Principal Chief Conservator of Forests to utilize this revenue under the user charges in the Wildlife Sanctuaries and National Parks towards maintenance and development.
