ii) Whether the Conservators of Ferests can permit the Dy. ROs who were appointed prior to 26.5.78 to retire from service on attaining the ago of superannuation and sanction pension and DCRG. The matter has been examined and clarified as belows:

For the persons who have been promoted as Dy. Ros by the Chief Conservator of Forests and pension and DCRG and family pension will be sanctioned by Chi-f Onservator of Forests after only. For the persons promoted by as Dy. ROs by Conservators of Forests after issue of G.O., cital the Conservator's family person etc. and forward final pension papers to Accountant Gararal direct.

2. Govt.in G.O.Ms.No.140/For/IV/77 F & RD(Dept) 1t. 15.12.77 communicated in COF RC No. 993/76/43, dt. 23. 3.77 have given clarification explaining the position. The Conservator of Forests, is however is informed that persons who have been promoted by the Chief Conservaof Forests as Dy. R.Os are to be permitted by Chief Conservator of Forests to retire from service and attaining their age of superannuation and the pension and DCRG will be sanctioned by the Chief Conservator of Forests only. Hence all the pension papers in all such cases should be submitted to Chief Conservator of Ferests.
