Sub: Change in detailed He ds of Classification of Minor Head, House Builling Advance - Opening of Omnibus detailed head - Orders Issued by Govt. - Reg.

Ref: G.M.Nc.29653/A/A&L-77-1 Fin. & Pls. (A&L) Dept. dt. 23.7.1977.

In the G.M. cased, Grvt. have issued instructions to all District Treasuries, District Treasury and Accounts and Pay and Accounts Officer, Hyderabad in regard to operation and maintenance of a single Omnibus detailed head, viz. Other "Officers" under the minor head "House Building Advances" below the Major Head "766-Loans to Government Servants with effect from April, 1977.

As a matter of fact, the accounts in respect of House Building Advance and Motor Conveyance Advance at present are being kept under the following heads.

House Building Advance.

- 1. A.I.S. Officers.
- 2. Gazetted Officers.
- 3. Section Officers.
- 4. Ministers.
- 5. Other Officers.

Meter Conveyance Advance.

- 1. Gazattad Officers.
- 2. Section Officers.
- 3. Other Officers.

To obviate certain practical difficulties that are arising in the above classification of House Building, Motor Car and Conveyance Advances, consequent on the issue of G.C.Ms. No. 437 Fin. & Plg. Department, dated 13.10.1976, the Govt. in Finance & Planning Department here issued further instructions to the Pay and Accounts Officer and all District Treasury Officers to chassify the House Building Advance and Motor Car and Conveyance Advances, under the following heads of accounts.

"766, Leans to Government Servants.

M. H. O5 HOUSE AND BUILDING ADVANCES.

S.H.(01) A.I.S. Officers.

S.H. (U2) Other Officers.

S.H. (03) Minis ers.

766 LOANS TO GOVERNMENT SERVANTS.

M. H. (10) Advances for purchase of Motor Conveyances.

S. H. (01) Purchase of Motor Cars.

S. H (02) Purchase of M tor Cycles.

In view of the above all the Divisional Forest Officers and Conservators of Forests are requested to adopt the above revised classification, in respect of House Building, Motor Car and Other Conveyance advances, while rendering Cash accounts (F.A.VII) to Accountant General for audit. The Officers are requested to follow the above instructions scrupulously. They are also requested to acknowledge receipt of this circular on the proforms given below.

MOVIBLE PROPERTY: The words "Movible Property" are intended to include corposeal property of every description, except land and things attached to the earth or permanently fastened to any thing which is attached to the earth.

(Section 22 of the IPC).

Wro gful gain is gain by unlawful means of properly to which the person gaining is not legally entitled.

(Section 23 of the IPC).

"OAH": The word "Oath" includes a solemn affirmation substituted by law for non 'oath' and any declaration regular or authorised by law to be made before a Public Servant or to be used for the purpose of proof whether in a court of Justice or not.

(Section 51 of the IPC).

GCCD FAITH: Nothing is said to be done or balieved in "Good Faith" which is done or believed without aus care and attention,

LEGIL REMUNERATION: The words Legal remuneration are not restricted to remuneration which a Public Servant can lawfully demand, but include all remuneration which he is permitted by the Govt. which he serves, to accept.

(Section 161 of the IPC).

"FORGERY" Who ever makes any false document or part of a document with intent to cause damage or injury to the public or to any person, or to support any claim or title intent to commit frauad or that fraud may be committed, commits forgery (Section 463 of the IPC).

'FRAUDULENTLY' A person is said to do a thing fraudulently if ne does that thing with intent to defraud, but not otherwise.

(Section 25 of the IPC).

"FORGED DOCUMENT". A false document made wholly or in part by forgery is designated as a Forged Document.
