In continuation of this office Circular instructions, 1st cited, it is informed that the snake skins are being illigally transported from Andhra Pradesh to other States. This has been brought to the notice of all the officers more than once. The Addl Chief Conservator (WL) Coimbatore through than once. The Addl.Chief Conservator (WL)Coimbatore through his letter 2nd cited has informed this office that (6) cases were booked at Madras Central Station from October,82 to April 83 and totally (3505) No.s of Snake Skins were seized by the Wild life staff of Tamilnadu State. It was also reported that the above skins were transported from Vijayanagaram, Nellore and Eluru Railway Stations and that these raw skins where booked either in parcel Vans/Break vans or in goods trains in small bundles in gunny sacks usually declaring them trains in small bundles in gunny sacks usua ly declaring them as some other commodity. Further, it is also informed that the snake skins are also being booked from Warangal/Kazipet stations. Generally the names of the consigner and consignee and de are ficticious and usually the offenders never turn up to take delivery of the seized consignment and the seizue were confiscated to their states.

The rule position in wile life (protection) Act.1972 is as follows: -

According to Sub-section(3) of Section 43 of Wild Life (p)Act.1972, 'No person who does not posses a certificate of ownership shall transfer or transport from one state to another state or acquire by transfer from outside the State any such animal, animal article, trophy or uncured trophy as is refered to in sub section (1) Except with the previous permission in writing of the Chief Wild Life Warden or the Authorised officer within whose jurisdiction the transfer or transport is to be effected!.

Thus a transport of snake skins from one State to another without possessing a Certificate of ownership and also without previous permission of Chief Wild life Warden or Authorised officer is punishableunder Wild life (P)act, 1972 vide item (23) Annexure II of this office Circular 10/83, dated: 30.5.1983.

ender :: 325 :::::: Letil de l'ender All the officers in the address entry are therefore instructed to take all effective measures to prevent illegal transportation of snake skins to other states so as to avoid exploitation of snak s for their skins in this state. It is also instructed to arrange constant vigil at all the Railway stations in their jurisdictions.
