The Accountant General has observed that the employee of Indira Gandhi Zoological Park who are drawing the pay in J.A. merged scales of 1979 and 1980 are eligible to draw daily allowance and mileage as per Govt.Orders issued in G.O.Ms. 215 Finance & Planning Jt. 26.8.81 and not at the rates mentioned in G.O.Ms.No. 20 dt. 11.3.1982 which are app;icable to those who are drawing in the non J.A. merged scales. The Accountant General has requested to recever the Excess Payment in all T.A. bills passed from 3/80 onwards in Indira Gandhi Zoological Park from all the employees.

It is impressed in all the Officers that the employees drawing lays 7. A. in the revised scales of 1979-1980 are eligible to draw only daily allowance and mileage as per G.O.Ms.No. 215 Fin ance dt. 26.8.83. The employees who continue to draw pay in pre-revised scales of pay i.e. pay in 1974 scales three man committee scales of 1976 only are eligible to draw daily allowances at the rates prescribed in G.O.Ms.No.70 Finance dt. 11.3.1982. So far in this effice is aware there are no such cases in our Department.

All the Officers are therefore requested to see that is D.A. (Daily Allowance) is claimed at the rates mentioned in G.O.Ms.70 Finance dt. 11.3.32, the excess amount may please be recovered and Compliance reported. The action taken may be reported to this office direct,
