Sub: - Forest Department - Officers from Mofussail visiting Hyderabad - Instructions Issued - Reg.

It is observed that Officers from Mofussail are visiting Hyderabad for Official work in the Office of the Chief Conservator of Forests or elsewhere. But not recored of their visit or work carried out is available in the Chief Conservator's Office. It is felt necessary to maintain a perfect of the visits made by officers from Mofussail in the Office of the Chief Conservator of Forests.

- 2. There are some standing orders in this regard. In surression of all other orders, the following instructions are issued.
- 3. The Conservators of Forests who visit Hyderabad should invariable call on the Principal Chief Conservator of Forests and the Chief Conservator of Forests Concerned. The other visiting officers of the Departurement should contant the Addl. Chief Conservators of Forests and in their absence the concerned Asst. Chief Conservator of Forests / Asst. Conservators of Forests and inform the result of their visit.
- 4. Since it is not possible to keep track without maintaining any record in Chief Conservator's Office it is found essential that the officers visiting Hyderabad should submit information in duplicate the following proforma and take back one copy duly signed by the concrned Addl. Cheif Conservator of Forests or Asst. Chief Conservator of Forests/Asst. Conservator of Forests of the Chief Conservator's Office for claiming the T.A.
