Sub: Estt. - F.D. - Forest Education A.P. School of Forestry, Yellandu - Selection of Foresters and F.G's for undergoing training in A.P. School of Forestry, Yellandu - Instructions for deputation for training - Reg.

Selection of the Foresters and Forest Guards for undergoing the training at the A.P. School of Forestry, Yellandu will be made based on their seniority only. Inspite of this it has been observed that subsequent to coloration and communication of been observed that, subsequent to selection and communication of lists of individuals, to be trained, certain Divisional Forest Officers and Conservators of Forests are coming forward with proposals for exempting certain individual from deputing for training for a particular period under some pleasor the other. training for a particular period under some plea or the other.
The reasons usually cited are pressure of work, Departmental
collection of beedi leaveswork etc. due to which they are not
able to send the individual for training able to send the individual for training.

Having sent the lists for deputation for training and subsequently requesting for exemption at the last moment or even immediately after starting of training, will lead to a situation of colors of colors to Boroston Bor wherein even selection of alternate Forester, F.Gs.becomes difficult. Thus the entire training programme gets upset and the training capacity of the school not fully utilised.

In view of the above position all the Conservators of Forests, are requested to relieve the Foresters/Forest Guards who have been selected for undergoing graining in A.P.School of Forestry, yell andu, as per the list communicated to them by the Conservator of Forests. Khammam without fail. In Case Towns the Conservator of Forests, Khammam without fail. In case max they are not in a position to send some of the Foresters or Forest Guards due to pressure of work (or) where any of the Foresters/Forest Guards are on long leave on medical grounds(or) any of them is under suspension (or) the Foresters/Forest Guards against whom charge sheets for grave of them are pending, they should indicate the same in the proposals charges are pending, they should indicate the same in the proposals itself while sending them to the Conservator of Forests, Khammam, so that their selection could be deferred until such time they have made available for training. However it should be realised that lack of training certificate would adversely affect promotion of Foresters/Forest Guards and exemptions should be sought for only under special circumstances.

The Conservators of Forests are requested to follow the above instructions scrupulously. The Divisional Forest Officers working under their control may also be instructed suitably.
