Immediate attention of all the Conservators of Forests /Divisional Forest Officers is invited to the above subject matter. While monitoring theimplementation of the conditions imposed by the Government of India/ Government of Andhra Pradesh in the cases approved for release of Forest lands for non-forest purposes under Forest (Conservation) Act, 1980, it is noticed in general, that the amounts paid by the user agencies towards the cost of acquisition of equivalent alternate lands and for raising plantations and its maintenance therein, were deposited in the F.R./843 Civil Deposits by the concerned Divisional Forest Officers, and in almost of the cases, it is found, that the amounts thus deposited in 843 Civil Deposits were diving lapsed without being utilized for the purpose due to the amounts the Compensatory Afforestation works. It is also puticed that the implementation of the stipulated consisting impressed by the amounts the stipulated consisting impressed by the amounts. tation of the stipulated corditions imposed by the equeroment of the India and State Government wile approving the projects for release of Forest Lands are still citaer unimplemented or partly implemented leaving the balance part at negelected state. It is most unforturate to remind that the very purpose of Forest Conservation Act, 1980 will be defeated if due in the conservation and the conservation act. if due importance is not given to the implementation of the conditions imposed, within the time limit, scruptously, especially in the cause where the company plantations are involved.

Secondly, at the eleventh hour, when a report was called for by this office regarding the stage of implementation of the conditions, it is being reported by some of the Conservators of Forests/ Divisional Forest Officers that the amounts deposited in '843 Civil Deposits' were not utilised for want of clear instructions from higher authorities and in some cases, the Conservators of Forests/Divisional Forest Officers are expressing doubts and

are asking for clarification now, ie. only after being reminded for action taken, regarding the procedure to be felliwed for utilising the funds towards compensatory plantations.

In view of the above mentioned lapses, the Conservators of Forests/ Divisional Forest ufficers are requested to note the following instructions and to take necessary action accordingly.

- i) The stipulated conditions shall be implemented scruplously and if any deviation is noticed, the same should be brought to the notice of this office for necessary immediate action/advice.
- ii) As and when the Compensatory amounts are received from the user agencies, they should be deposited (under intimation to this office) under the appropriate head of account correctly i.e.)
 - a) The amounts received towards the cost of tree growth of timber/fuel extraction charges etc. in FR 882;

b) The amounts received towards the cost of compensatory Plantation and their maintenance including the cost of acquisition of Compensatory lands in certain case where there is specific condition to collect the cost of acquisition of Compensatory Afforestation areas from user agencies, snall be deposited under '843 Civil Deposits' as instructed in the G.U.Ms.No.47635/For~IId 82-2, dt.2.4.83, communicated to all Conservators of Forests/Divisional Forest Officers in this office Ref.No.41570/82-64, dt.2.7.83, and to utilise the same fully towards the said purpose within the (3) years period from the year of deposits. The procedure to be followed for the utilisation shall be as specified below:

"first the amounts paid by the user agencies should be deposited under the Head of Account 882 f.R. cash remittances Minor Head No. (as per the Head of Account of user agency from who the funds were received) then the classification in the FAVII under 843 Civil Deposits (Minor Head) 18 FirestDeposits (Receipts) whenever the expenditure is booked for the works carried out for raising plantations and its maintenance etc., it may be booked from the same head of account i.e. minus entries under 843 Civil Deposits'. The plus and minus entry in FA VII and a schedule should accompany the FAVII relating to the menth showing the deposit available at the begining the month.

iii) As the issue of creation of non-papsable funds is under correspondence with the Accountant General and Government of Andhra Pradesh and will take some moretime to get the apartial of the said facility, the Conservators of Forests/Divisional Forest Ufficers are requested to see that the amounts paid

by the user agencies are deposited under '843 Civil Deposited and are utilised within the period of 3 years thereby avoiding lapsing of the funds.

iv) For any doubts and clarifications while implementing the stipulated conditions, the Divisional Forest Officers are requested to bring them to the notice of this office or to the notice of concurred conservator of Forests immediately without any delay, so that the doubts or clarifications are met with and necessary instructions are given to the Divisional Forest Officers in time avoiding delay in implementation of the conditions.

It is further requested to submit a statement showing the Compensatory Afforestation funds so far received from the user agencies, how they are invested/utilised and dates of their lapse, in the prescribed proforma enclosed, to reach this office before 30.11.1988 without fail. This should be submitted, quarterly, infuture ie. office before 10th of next month.

The receipt of this letter should be acknowledged by return of post.
