

security deposit. The amount of security deposit may be kept at a minimum of Rs. 5,000 and a maximum of Rs. 10,000/- depending on the turn-over the Saw Mill, and this amount may be fixed by Divisional Forest Officer concerned.

- (iii) In the event authorisation of saw mill owner for issue of permits, invariably, the property mark of saw mill owner is to be registered.
- (iv) The Divisional Forest Officer need not superscribe the mode of transport on each permit. He may issue the required permits to permit issuing person. And the person, who actually issues the permit is to superscribe on the permit the mode of transport used depending upon the vehicle or conveyance engaged.

All the Officers are requested to note the instructions mentioned above and deal the Saw Mill cases accordingly.

But instances have come to notice where the enclosure boundaries have been encroached on the plea of lack of clear cut boundary demarcation in certain blocks and the Department has been finding it difficult to check these encroachments without resorting to litigation. A recent case has come to notice where a Forest Department had encroached on 35 acres of Forest land which led to legal complications under the Forest Conservation Act.

Therefore all the Divisional Forest Officers are requested to see that all the boundaries of the enclosures in each forest block of their division are verified with the admitted maps and are maintained with clear cut and well demarcated boundaries with the prescribed size of ~~signs~~ coins on a priority basis based on the original notifications. This work should be completed within 2 months from the date of receipt of this circular. It is also suggested that all points of issues like Roads, paths etc. clear cut sign Boards be put up informing the fact that the person on persons one now entering in R.F., P.F. etc.,

The Conservators of Forests are requested to make it a point to inspect these boundaries during their tours in the division and satisfy themselves about the state of these enclosure boundaries. The Conservators of Forests are requested to initiate drastic action against any lapses noticed in their tours.
