Sub:- FOREST DEPARTMENT- Fixation of Rent for
Occupation of Forest Rest/Guest Houses/ Inspection
Bungalows - Regarding.

Ref :- Arising.

* * *

1. There are Forest Rest Houses/Inspection Bungalows/Guest Houses constructed by the Forest Department and maintained at various places in the State. These buildings were classified differently in the past for purpose of charging rents from the occupation on the basis of accommodation and facilities available. At present all the Forest Rest Houses/ Inspection Bungalows are provided with almost similar accommodation and modern facilities. Therefore there is no valid reason to have different rates of rents to be charged from the occupants. Further the conservators of Forests/Divisional Forest Officers have been fixing rents differently in each circle and divisions and there is no uniformity.

2. In order to obtain uniformity in the matter of charging rents for the occupation of Forest Rest Houses/ Inspection Bungalows throughout the State in future the following rates of tariff are fixed superceding all the orders issued by this office, Conservators of Forests and Divisional Forest Officers in this regard. These orders will come into effect with effect from 1-10-1992 if they do not synchronise with the tariff rates now ordered.

1) For Forest Officers either of Andhra Pradesh or of other States or of any Country Serving or Retired- For one Suite of Accommodation :

2) For Officers of other Departments State or Central serving in Andhra Pradesh or other States or of any Country-For one Suite of accommodation ;

3) General Public for one Suite of accommodation;

4) Persons connected with Film field - For one Suite of accommodation:

- i) Single person Rs. 300/- per day or fraction thereof.
- ii) For each extra person Rs. 50/- - do -

Note:

a) For categories listed in (2), (3) and (4) above in no case more than (4) persons shall be allowed in each Suite even on payment of extra charges towards rent.

b) i) Fraction of a day also shall be counted as a day for the purpose of charging rent. No half day rent will be reckoned.

ii) Children over 12 years of age shall be treated as adults and children under 12 years shall not be counted as extra member/s if accompanied by their Parents or Guardians.

e) The occupation of the Forest Rest Houses is further governed by the relevant rules of the Department.

d) Rights of reservation shall rest with the Forest Department under the authority of Officers of above the rank of the Forest Range Officer having jurisdiction over the area.
