Sub:- Estt.- Forest Department- Transferees and
postings-Flying Squad Parties-Instructions-
reiterated.

The procedure to be followed in posting and transfer of
personnel to Flying Squad Divisional/Parties was outlined in
the references cited.

1. 1. In the reference 1st cited, among other things, it
was suggested that best of the available Subordinates with
aptitude to work in the Flying Squad party should be posted.
As the work is of fatiguing and sensitive nature, no
Subordinate should be retained for more than one year on
duty right from the Jeep Driver to the Range Officer,

1.2. In the reference 2nd cited, it was made clear that
the Range officers to be posted to Flying Squads will be
selected by the Chief Conservator of Forests. However, the
Foresters, Forest Guards and Drivers will be selected by
the Flying Squad Divisional Forest Officers and the respective
Conservators of Forests have to post the personnel selected
by the divisional Forest Officers Flying Squad parties even
if it means sacrifice for the Conservators of Forests of some
good subordinate staff. The persons should be shifted in
rotation and not to change the entire staff at one time only.

1.3. In the reference 3rd cited, it was informed that the
choice of posting of Senior Assistants to Flying Squad Divisions
(U.D.Cs.) should be left to the Conservators of Forests.

1.4. In the reference 4th cited, it was instructed that in
the case of Attenders (Peons) the transfers should be effec-
ted once in 6 months, leaving the choice of selection
to the Divisional Forest Officers, Flying Squad Divisions.

2. In the context of several changes brought out with
the organisation of local cadres etc., the above instructions
require some modifications. The Conservators of Forests
and Divisional Forest Officers, Flying Squad Divisions are
requested to follow the procedure indicated below with
immediate effect.

2. 1. The Conservators of Forests who have got administrative
control over the Flying Squad and vigilance parties will
process the selection of staff to be posted to these
divisions or parties by obtaining the views of the concerned
Flying Squad or vigilance Divisional Forest Officer and
then issue posting orders. A person once

posted should not be kept for more than one year under any circumstances as these posts are highly sensitive and focal and these staff should not develop vested interests. All the personnel of different cadres should be transferred once in year and the transfers, as far as possible, should not be made in the middle of academic Year. The substitutes should be young (in any case not above 40 years) good at work, reliable and should have aptitude to work in Flying Squad units.

2.2. Those who have already completed one year stay in flying squad and vigilance parties as on the date of issue of this circular, should forthwith be shifted. Thereafter, the above instructions should be followed in letter and spirit.
