Sub:- Seedlings – Supply of seedlings of economic value to the farmers and
public – Regarding.

No.28283/For.VI-1/92, dated 24-11-1992.

The District Collectors, during the State Conference held at Hyderabad on 16-11-1992 brought to the notice of the Government that the Forest Department is supplying only eucalyptus and Subabul seedlings under free distribution programme under Social Forestry. The Government felt that instead of these exotic and un-economical species, trees and species of indigenous origin capable of yielding economic returns in terms of usufruct be raised extensively for supply.

2. The Conservators of Forests/Divisional Forest Officers are requested to be careful and judicial in raising of eucalyptus and Subabul and give reference for species of indigenous origin and public utility and yielding non-wood forest products, keeping in view of the demand from the public in this regard. This is to ensure that the economic returns of the trees so planted reach the rural poor and also to discourage the exotics and encourage the growing of indigenous tree species.
