Sub:- National Park - Kasu Brahmananda Reddy National Park, Hyderabad -  
Permission for Walking and Jogging - Regarding.

\*\*\*

As per the powers delegated under Sec.28 of Wildlife (Protection) Act 1972, the following rules and regulations are framed for permitting entry into the Kasu Brahmananda Reddy National Park for the purpose of Walking and Jogging.

This Circular is issued without prejudice to the final notification i.e., to be issued under section 35 (4) of Wildlife (Protection) Act 1972. These orders are also subject to the result of the writ petition No.775/94 and are issued during the pendency of the same.

The intending walkers are permitted to walk in the Kasu Brahmananda Reddy National Park in Hyderabad subject to the following.

1. Each intending individual to walk has to get his name registered in the office of Working Plan Officer, Hyderabad (Officer incharge of the National Park) whose office is located in Aranya Bhavan, Saifabad Hyderabad by paying one time registration of Rs.100/- (Rupees one hundred only) and an annual fee of Rs.5/- (Rupees five only).
2. Each intending individual once registered has to obtain an Identity Card from the Working Plan Officer, Hyderabad. For this he has to produce two passport size photographs with his specimen signature, the cost of the card is to be borne by the applicant.
3. Forest Department is not be responsible for any unto-wards incidents accidents that may occur due to any flora or fauna.
4. The intending Walkers on compliance of the above conditions will be allowed to walk in the Kasu Brahmananda Reddy National Park between 5.00 a.m. to 8.00 a.m. and 4.00 p.m. to 6.00 p.m. each day.
5. The Forest Department reserves the right to close the park for the walkers, in the exigencies of Management of the park when ever required, which fact will be notified on a board at the entry gate before such closure.
6. The Walkers are requested to observe the following:
  - shall not carry any weapons
  - shall not cause any damage to the habitat, which includes rocks and soil, all vegetation etc.,
  - shall not harm, kill, trap on snare any wild animal in the National Park
  - shall help in prevention of commission of any offence within the National Park.
  - shall not take any pet animals inside the National Park
  - shall not deface or write on any surface including the boulders, trees and boards
  - shall not cause any fire
  - shall not smoke in the park
  - shall not enter the properties of Nizam, located inside the National Park.
7. Entry of all vehicles including cycles is prohibited.
8. Congregation, Gathering or holding of meetings workshops or camps is not permitted
9. The walkers are requested to show their identity cards on demand by any forest/ Police official on duty, to restrict entry of unsocial elements into the National Park.
10. The entry fee for other visitors shall be Rs.2/- per day.
11. Children from recognised schools will be charged at Rs.0.50 ps. Per child per day.
12. All Handicapped children will be given free entry.
13. On all National holidays like 26<sup>th</sup> January, 15<sup>th</sup> August, 2<sup>nd</sup> October and on Vanya Prani Saptah Week or Vanamohotsava Day entry will be free.
14. Entry will be from 8.00 a.m. to 6.00 p.m. for general public.
15. Advertisement will be permitted on suitable payment on the wall outside. Eco-friendly advertisement would be permitted to be put up on payment of annual fee of Rs.10,000/- or as may be fixed by the Chief Wildlife Warden Andhra Pradesh from time to time for such periods as the Chief Wildlife Warden decides at suitable places to be decided by the Chief Wildlife Warden. His decision on the type, size and colour the matter and where to put would be final.
