Sub:- Amounts due by the Girijan Co-operative Corporation Ltd. For Minor Forest Produce units leased to the G.C.C. - Regarding.
Ref:- This office Rc.No.27321/93-D1(II), dated 17-7-1993.

The Forest Department has leased out Minor Forest Produce units to the G.C.C., Visakhapatnam on the basis of the following instructions of the Government.

As per the information furnished by the C.Fs the G.C.C.Ltd., is due Rs.13.80 crores as on 31-12-1994. The Conservator of Forests are furnishing the arrears due by the G.C.C. Ltd. Incorporating the same in the quarterly returns of arrears which include all other items of Forest arrears. To keep a close watch on the payments due from the G.C.C.Ltd., and to take necessary steps to recover the huge arrears from the G.C.C. Ltd. A separate quarterly proforma is now prescribed. The C.Fs and the D.F.Os are requested to furnish the information at the end of every quarter.

As per the provision of Agreement executed by the Pri.C.C.F. with the V.C.& M.D., G.C.C. Ltd., Visakhapatnam the G.C.C. Ltd., have to make payment in two installments, 1st installment will be paid at the end of June and 2nd installment at the end of December every year. For delayed payment the G.C.C. Ltd. Have to pay interest @ 22% per annum. Accordingly the proforma is prepared. The C.F's to obtain the required information from the Divisions of their Circles and submit within a fortnight of expiry of each quarter. As per Agreement condition No.11 the G.C.C. Ltd. Have to pay minimum rentals equal to the average of the previous three years rentals for each MFP

The DFOs and the C.Fs. should therefore to calculate and collect the rental accordingly for every lease unit. The C.Fs are further informed to ensure prompt recovery of dues from the G.C.C. Ltd. They should hold quarterly meetings both with the DFOs and the G.C.C. Officers. The Conservators are requested to submit the information of arrears as on 31-3-1995 by 15-6-1995 and for other quarters regularly within 15 days after expiry of the every quarter without fail. From now onwards the DFOs are personally held responsible for timely collection of dues from the lease year 1994-95 onwards. For non-payment of dues from 1994-95 lease year, the DFOs should initiate and take action as per provisions of Agreement.

The above instructions should be followed scrupulously, failing which it will be viewed seriously and action will be taken against all concerned.
