Sub:- Allotment of funds to Divisions and Circles by other agencies like D.R.D.A. and D.P.A.P. at District level - Non-availability of information at Prl.CCF office level.

It is observed that many of the Conservators of Forests and Divisional Forest Officers are not keeping the Principal Chief Conservator of Forests office informed of the funds being allotted separately to the Divisional Forest Officers and the Conservators of Forests at District level from agencies like DRDA, DPAP, Waste Land Development, Drought relief, Cyclone relief, Employment Guarantee and Assurance Scheme and other funds at the disposal of the District Collectors. With these funds, the Divisional Forest Officers (both Territorial and Social Forestry) and some times Divisional Forest Officers (W.L.) are carrying out works like afforestation, cultural operation and other improvement works, boundary line clearance, fixing of fire-line clearances, improvement of water sources in the Reserve Forest areas etc., in their respective jurisdiction. The Prl. Chief Conservator of Forests office does not have the records of the same to monitor such expenditure. The Conservators of Forests are directed to obtain such information from Divisional Forest Officers and send information of such allotment, target fixed for the works. expenditure incurred and targets achieved in the proforma enclosed. Copies of the such information should also be marked to Chief Conservator of Forests (SF)/Chief Conservator of Forests (D). If the Wild Life works are included the same may also be sent to the Chief Conservator of Forests (W.L.). These instructions will come into force with immediate effect and such information should be furnished by 15th of the every succeeding month i.e., the information of December, 1995 to be submitted to the Prl. Chief Conservator of Forests by 15-1-1996.

The receipt of these instructions be acknowledged by 15-1-1996.
