CIRCULAR No.10/96

Sub:- High Court and Andhra Pradesh Administrative Tribunal - Preparation of Counter Affidavits - formats furnished. Ref:- G.P., High Court Lr.No.95/VTR/Forests, Endts.& Energy, dtd. 24-9-1996.

It is seen that in various cases before the High Court, as well as the A.P. Administrative Tribunal, the parawise remarks/counter affidavits are not prepared properly, thereby Government Pleaders are to spend lot of time in correcting the parawise remarks. With the increase in volume of work, the Government Pleaders are not able to approve the para-wise remarks at the earliest. To facilitate early approval of the parawise remarks, the following instructions are being issued along with formats of counter affidavit for guidance of the field officers.

HIGH COURT

- The Format of counter-affidavit to be adopted is indicated in Annexure-I. parawise remarks to the affidavits should be prepared in the format indicated.
- 2. If there are no remarks for a particular para in the affidavit it may be indicated in the draft counter affidavit being furnished to Government Pleader, but need not be typed on fair copy of the counter affidavit.
- 3. The draft and fair copies of the counter affidavits should be types in $1\frac{1}{2}$ space in both
- 4. The enclosures, if any, should be indexed and the page numbers should be given to all such enclosures for easy reference during the course of arguments. All photo copies of the documents enclosed should be duly attested.
- 5. (6) sets of fair counter affidavits and enclosures, if any, should be furnished to Government Pleader, High Court.
- 6. In contempt cases, apart from the parawise remarks in the format, a Vakalat form duly signed by the Officer against whom the contempt is filed should be furnished with a demand draft for Rs.500/- in favour of Mr.V.Tulasi Reddy, Government Pleader, High Court and another draft for Rs.250/- in favour of Mr.B.Ram Reddy,
- Whenever the counter affidavits are to be filed in cases questioning orders of the Conservator of Forests/Prl.Chief Conservator of Forests to Government, the parawise remarks should be approved by such authority, though the fair copies can be filed by Divisional Forest Officer concerned.
- 8. The fact of filing of counter affidavits in writ petitions/contempt cases etc., should be informed to Asst.Conservator of Forests (Law) O/o the Prl.Chief Conservator of

- 3. The draft and fair copies of the counter affidavit should be typed in 11/2 space on one.
- 4. The enclosures if any, should be innexed and page numbers should be given to all such enclosures for easy reference during the course of arguments. All photo copies of the documents enclosed should be duly attested.
- 5. (6) sets of fair counter affidavits and enclosures, if any, should be furnished to
- 6. In contempt cases, apart from parawise remarks in the format, a vakalat form duly signed by the officer against whom the contempt is filed should be furnished with a demand draft for Rs.650/- in favour of Sri M.Padma Rao, Government Pleader.
- 7. When the orders of the Conservator of Forests/Prl.Chief Conservator of Forests/ Government are questioned in O.A., the parawise remarks should be approved by such authority, though the fair copies can be filed by the Divisional Forest Officer
- 8. If interim orders granted by the Tribunal are to be vacated, a vacate stay petition in format given in Annexure-III should be furnished along with copy of interim order and grounds for praying vacation of interim orders. Six sets of the above mentioned documents should be furnished to the Government Pleader, A.P.A.T.
- 9. When interim orders or stay orders are granted by the Tribunal, vacate stay petition should be filed after filing counter affidavit.
- 10. Generally, the interim orders or stay orders once granted are extended from time to time till it is vacated or O.A. is disposed off. No action should be initiated on expiry of stay or interim orders without specific order either from Tribunal or any intimation from the Government Pleader indicating the vacation or expiry of interim orders.
- 11. The fact of filing of counter affidavits in O.A./C.A.N.N.A. should be informed to Asst. Conservator of Forests (Law) O/o. the Prl.Chief Conservator of Forests, A.P.

GENERAL

In High Court and A.P.A.T. cases for getting approval of parawise remarks, a responsible person, dealing with the subject may be sent to meet the Government Pleader, alongwith records.
