Sub:- Forest Dept. – Rewards to informers under the A.P. Forest Reward Rules and the S.S.F. Payment of rewards – Instructions – Issued.

Ref:- 1) G.O. Rt.No.323, EFS&T(For-II) Dept., dt.30-7-1997 / 2) CCF Cir.No.27/79 in Rc.No.37603/79/F3, dt.5-8-1979. 3) PCCF Rc.No.10895/94-X1, dt.3-10-1994.

In the reference 1st cited the Government have allotted an amount of Rs.20.00 lakhs in order to strengthen the secret information system more effectively with an ultimate objective to provide better protection to the forest wealth in the state. If this information system is built systematically with telling effectiveness not only the Forests will be better protected but also more revenue can be realised by way of compounding fee.

- 2. In order to keep the information system so built alive in future, it is imperative on the part of the Forest officials to keep the names of the persons who furnish the information as guarded secret in Public interest. These persons who render useful service by furnishing information leading to detection of forest offences involving forest produce of great value, will have to be duly remunerated. The Government in the G.O. 1st cited have accorded permission to exercise discretion in sanction of the amounts under Secret Service Fund upto the limits of Rs.500/-, Rs.2500/-, Rs.5000/- and 'No limit' in respect of Forest Range Officers, Divisional Forest Officer, Conservator of Forests, Prl.Chief Conservator of Forests respectively.
- 3. Accordingly to the reference 2nd cited above it was informed that the Chief Conservator of Forests only was the competent authority to draw and disburse the amount. Definite orders from the Chief Conservator of Forests for payment under Secret Service Fund were to be obtained by the Divisional Forest Officers. However, in the G.O. 1st cited above mentioned all the officers, right from the rank of Forest Range Officer to Prl.Chief Conservator of Forests, have been delegated with powers to sanction the amounts under Secret Service Fund as mentioned in the para (2) of the G.O. cited.
- 4. In order to utilize the funds from Secret Service Fund and to keep the names and addresses of the informants texts a guarded secret both in the sanction order and voucher and any other official document the following procedure is formulated to be implemented by the Forest Officers:-
- a) A requisition in the proforma in the Annexure-I enclosed herewith, shall be submitted to the Forest Officers mentioned in para (2) above for sanction of amount to be incurred towards contacts and informants under Secret Service Fund. This requisition shall be with reference to the information obtained leading to better protection of forests.
- b) Upon receipt of requisition in Annexure-I, the competent Forest Officer shall issue sanction order, in the proforma in Annexure-II, depending on the genuinity of the requisition. This sanction order will be the voucher for the cash book, which shall be numbered according to the cash book.
