Sub: - Visits of members of the IBWL and Steering Committee of Project Tiger to National Parks & Sanctuaries.

In the recent past, we have received some complaints regarding proper courtesy and facilities not being extended to the non official members of IBWL/Steering Committee of Project Tiger during their field visits to national parks and sanctuaries. Such visits are normally undertaken on the directions of the IBWL/Steering Committee of Project Tiger or at the initiative of the members themselves. In order to avoid any misunderstanding and confusion on this account, it has been decided to follow the guidelines as set out hereunder:

i) Visits undertaken by the members on the directions of the IBWL/Steering Committee:

In such cases, the tour programmes of the members would be be approved by the Ministry of Environment & Forests, who will also meet the TA/DA expenditure on such visits. The state Govts. may kindly treat the members undertaking such visits at par with Govt. officials and charge rates that visits at par with Govt. officials on duty. Facilities like are applicable to Govt. officials on duty. Facilities like transport and accommodation, wherever required, may be provided for accomplishing the task assigned to the members by the IBWL/Steering Committee of Project Tiger.

ii) Visits undertaken by the members on their own initiative:

This Ministry would not reimburse the TA/DA cost of such visits. The members undertaking such tours should communicate their programme to the national park/sanctuary authorities well in advance so that their field visit could be facilitated by them. The States/UTs may consider allowbe facilitated by them. The States of accommodation on payment of ing the members to stay in Govt. accommodation on payment of rates as applicable to Govt. servants.
