Sub:- Supreme Court and High Court Cases – Monitoring of cases – instructions
– Regarding.

It is observed that number of cases are being filed in Supreme Court/High Court wherein Government and Prl.Chief Conservator of forests are respondents, and in many of the cases, Government and Prl.Chief Conservator of Forests are served with contempt notices, for want of implementation of directions. The contempt proceedings could be avoided, if there is constant monitoring of the cases, therefore, the following instructions are issued with immediate effect.

1. All cases in Supreme Court/High Court wherein Government/Prl.Chief Conservator of Forests are respondents should be informed to F.II Section/Asst. Conservator of Forests (Prod.) furnishing copy of affidavit, counter affidavit, judgement copies. The concerned section (incharge of subject in question) should process the case and keep F.II section informed.
2. All APAT/CAT cases should be dealt with similarly in 'Z' section.
3. A weekly review of pending cases would be done by Chief Conservator of Forests (W.L.) or Prl.Chief Conservator of Forests every Saturday.

Sub:- Supreme Court and High Court Cases – Monitoring of cases – Certain
modifications issued to Circular No.3, Dated 7-3-1998 – Regarding.
Ref:- PCCF's Ref.No.10364/98/F6, Dated: 7-3-1998.

In partial modification of Circular No.3/98 the following instructions are made.
The para 2 of the Circular No.3/98 should be instituted by the following:

2. All cases of APAT, dealing with establishment matters of executive upto the level of Forest Range Officers will be dealt by Assistant Chief Conservator of Forests (E) office of the Prl. Chief Conservator of Forests. Similarly all cases pertaining to Prl. Chief Conservator of Forests office establishment, and all cases pertaining to other Gazetted Officers of the Department will be dealt by Conservator of Forests (E), under overall guidance of Chief Conservator of Forests (Admn.).
3. All cases of CAT will be dealt by Conservator of Forests (E), under the guidance of Chief Conservator of Forests (Admn.).
