Sub:- F.D. - WL - Certain guidelines for submitting proposals -

issued.

Ref:- PCCF Circular No. 2/2007/WL-3 communicated vide PCCF Re.

No. 40355/07/WL-3 dated 31.12.2007.

It is observed that in most of the cases, whenever any proposals are submitted by the circle offices for financial assistance for taking up ecotourism activities, they are not submitted in complete shape and precious time is lost in correspondence for getting the proposals in the right shape. Therefore the following guidelines are issued for submitting proposals for seeking financial assistance for taking up eco-tourism activities.

- Under ecotourism emphasis should be to harness non-consumptive use of natural and aesthetic resources.
- The quality of experience shall be given preference over the number of visitors.
- Ecotourism activities can be taken up in Forest areas as well in Protected Areas.
- When ever ecotourism activities are proposed for Protected Areas it has to be necessarily community based.
- Whereas ecotourism activities in forest areas can be community based or otherwise.
- Ecotourism can also be taken up without involvement of communities, but efforts should be made to involve the communities.
- Detailed guidelines were issued vide the ref. cited (Copy enclosed) for implementing community based ecotourism in reserve forest areas and Protected Areas of Andhra Pradesh.
- For forest areas, development of tourist facilities would amount to non-forestry activity and will require due clearance under the Forest(Conservation) Act, 1980. Hence no permanent structures should be constructed for ecotourism in the forest areas. For accommodation /toilet facilities, only temporary structures like huts/collapsible structures may be used after obtaining due clearance under the Forest (Conservation) Act.
- There shall be a complete ban on disposables like plastic /non biodegradable material by tourists inside the forest areas/protected areas, and proper arrangements for waste disposal should be ensured.
- The impact of each and every activity in the natural resources and local community shall be monitored and kept within acceptable limits.
- The provisions of the Indian Forest Act 1927, Wildlife (Protection) Act 1972 and Forest (Conservation) Act 1980, etc., and the directions and guidelines issued by the Central Government from time to time shall be strictly followed.
- Accommodation should be in the form of tents or of prefabricated material.
- Every proposal should be in the form of a project and work plan for next five years duly indicating the year wise infrastructures to be created, financial requirements and year wise revenue expected to be generated.

- If further financial assistance is sought for any existing CBET / Ecotourism site, full justification for additional requirement should be given. However complete project proposals should be prepared even for these projects and the existing infrastructure should be indicated and subtracted from the total requirements. For existing projects the information sought vide PCCF Re. No. 24326/07/WL3 dated 28.01.2011 should also be enclosed in the project proposals. A small write up should be given for each of the proposed items /activity duly indicating if the location falls inside the PA /Forest area/Revenue land / Other Govt. lands etc.
- The Proposals for ecotourism should contain location of works with Lat / Long on a map. Correct quantities of work should be specified with unit cost based on FSR /SSR. Works proposed as "LS" or "As per actuals" will not be permitted. Justification should be given for works proposed.
- Economic sustainability of the Eco-tourism project should be furnished with income from various sources and expenditure on manitainance. The projects proposed shall be self sustaining as continued Government support will not be feasible.
- An indicative list of items for which funds can be sought for taking up the ecotourism activities is enclosed at Annexure –I
- An indicative list of items/ activities which could be of attraction for the visitors in eco-tourism sites is at Annexure -II
- An indicative list of Income generation items / activities/opportunities for the local host communities to engage themselves in ecotourism projects is at Annexure—III
- An indicative list of items / activities on which information should be enclosed in the project proposals is at Annexure –IV.

All the CCFs/CFs of Territorial and wildlife circles are requested to submit proposals for ecotourism as per the guidelines issued. The proposals already submitted by various circles for 2011-12 shall also be submitted as per the guidelines now issued in format given in Annexure-IV. All proposals for ecotourism shall reach this office by 10th March 2011 positively as the proposals have to be consolidated in the form of Annual Action Plan for 2011-12 and placed before the CAMPA Steering Committee for approval. This may be treated as most urgent.

Indicative items for which funds can be sought for taking up eco-tourism activities.

- Simple, adequate boarding & lodging facilities, in tune with the environment & the general setting of the landscape.
- Road network within the identified tourism zone.
- Self guided Nature trails.
- Transportation options.
- Interpretive Centres.
- Way-side exhibits.
- Sign boards and hoardings.
- Observation towers.
- Garbage disposal facility.
- Periodic training programmes on eco-tourism for tourism administrators, planners, operators, EDC /VSS members.
- Energy & water saving devices should be used apart from controlled sewage disposal.
- Control of noise pollution, chemical pollution and air emissions.
- Reduced use of environmentally unfriendly items like asbestos,
 C1S, pesticides, inflammable material.
- Respecting the historic & religious sites in the area
- Local participation.
- Boarding, hospitality, tour guides.
- Fair weather road network
- Tracks, self guided nature trails
- First aid facility
- Training for skill development,
- Rock climbing, tree machans
- Printing pamphlets for dos and don'ts, entry permits.
- Revolving funds
- Amphitheatre
- Boats, Cycles
- Wilderness Safari, Wildlife viewing through elephant back / hides
- Over night camping at designated camping sites in forest area.

- Interpretation /Eco centres/ Orientation centre.
- Nature trail.
- Vísitors centre.
- Museum, Amphitheatre, Road-side exhibits.

- Road-side Markers.
- Literature.
- Light & sound display.
- Vehicular excursions.
- Picnic spots.
- Canoeing / boating.
- Pony rides.
- Village visit.
- Ethnic / Folk dance.
- Bird club.
- Souvenir shops.
- Cycle trail.
- Wilderness Safari
