The attention of the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Hyderabad is invited to the references cited and a copy of the reference 3rd cited is enclosed.

2. The Government Pleader for Forests, High Court of Andhra Pradesh & Telangana has requested to issue written instructions on WP No. 29297/2016 filed Sri Tamatam Veerbhadra Rao and Telagamsetti Rama Krishna Shankar, R/o Uppalapaadu, Gandepalli Mandal, East Godavari District in the Hon'ble High Court of A.P & Telangana against the G.O Ms. No. 58, EFS&T (Section-II) Dept. Dated.8-6-2016.

3. In this connection it is to inform that the orders issued by the Government in G.O Ms. No. 58, EFS&T (Section-II) Dept. Dated.8-6-2016 for simplification of process for Tree felling Permission under the provisions of relevant Acts and Rules are applicable only for the purpose of establishing new industry. The objective is to facilitate for Ease of Doing Business for establishment of new industries in industrial clusters. The industries are also required to obtain various other clearances including Environmental clearance. Therefore, organized industries that are subject to various checks and balances cannot be compared to individuals. Accordingly, the procedure in the G.O Ms. No. 58, EFS&T (Section-II) Dept. Dated.8-6-2016 is not applicable to individuals or existing industries.

4. The Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Hyderabad is therefore requested to depute the concerned Additional Principal Chief Conservator of Forests to the O/o Government Pleader for Forests, High Court of Andhra Pradesh & Telangana to brief the same and enable the Government Pleader for Forests to place it before the Hon'ble Court on 06-09-2016.
