The Tenderer should possess an experience certificate and other Certificates like Registration of Firm if applicable, CST, VAT, GST registration as per applicability, Latest Income Tax Assessment order, should be enclosed invariably along with the tender schedule. In case of non-submission of these certificates, the APFD authorities reserve the right to take any appropriate action including the cancellation of tender of the respective Tenderer. In this regard the decision of the Tender Opening Authority / Chief Conservator of Forests (IT) is final and binding on all the Tenderers without any recourse.</li> <li>4. The bidder must have experience in providing Integrated AMC for last 2 years as on bid calling date.</li> <li>5. The bidder must have minimum experience of providing the Services to Minimum two (2) organisations.</li> <li>6.
