Therefore the persons connected with the above 19 vehicles are directed to show cause as to why the Red sanders logs together the 19 vehicles should not be confiscated to the State within 15 days from the date of publication of the notice in the daily newspapers either personally or through their defense counsel, failing which the vehicles along with the produce will be confiscated to State without any notice.
