**REVISED TENDER NOTICE, DATED 07.11.2014.**

Global Tender for sale of Graded Red sanders wood  
(*Pterocarpus santalinus*)

In pursuance of authorisation given by Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) and Director General of Foreign Trade (D.G.F.T.), Government of India under EXIM Policy permitting export of red sanders wood in log form, the Government of Andhra Pradesh, Hyderabad, India, had notified sale of about 4160 MTs. of graded red sanders wood stored in A.P. Forest Department Depots located at Kadapa, Bhakarapet, Tirupati, Udayagiri, Kanigiri, Adurupally and Venkatagiri from 10.10.2014 to 17.10.2014 which was postponed due to certain administrative contingencies.

The Director General of Foreign Trade, Government of India, vide Notification No.96(RE-2013)/2009-2014, dated 05.11.2014 has accorded extension permission by (6) months to sell and export red sanders wood by Government of Andhra Pradesh latest by 30<sup>th</sup> April 2015 and further mentioned that the permission granted is subject to such orders, as passed by the Hon'ble High Court of Madras or such submissions as made before the Hon'ble High Court of Madras in W.P.No.29273 of 2007 or such orders as passed by any other court, if any. Andhra Pradesh Forest Department have taken legal opinion from the competent authority. The competent legal authority of Government of Andhra Pradesh has opined that order of Hon'ble High Court of Madras in W.P.No.29273 of 2007 is not relevant to the proposed e-auction by Government of Andhra Pradesh, which is called only after taking prior permission from the competent authorities i.e. CITES and D.G.F.T., W.P.No.29273 of 2007 has been already dismissed by the Hon'ble Court and advised the State Government to go ahead with the proposed global e-auction-cum-e-tender. Details can be seen on the website of the Forest Department and it will be also shared through e-mail with the prospective bidders. It is further certified that as on date, there is no order from any Court in India restraining Government of Andhra Pradesh from the proposed global tender.

Government of Andhra Pradesh, India hereby notifies that the above notified quantity of red sanders wood will be sold by e-tender-cum-e-auction through MSTC Ltd. from 24.11.2014 to 01.12.2014.

The intending tenderers or their representatives can inspect the lots notified for sale on any working day between 10:30 a.m. to 05:00 p.m. upto 22.11.2014. The intending domestic and international tenderers shall register themselves with the M.S.T.C. Ltd.
