ORDER:-

The Director General of Foreign Trade, Department of Commerce, Ministry of Commerce and Industry, Government of India, New Delhi in their Notifications 1st read above, have accorded permission to the State Government of Andhra Pradesh to export 8498 MTs. of Red Sanders wood in log form out of the confiscated /seized stock available with the State Government of Andhra Pradesh either by itself or through any entity/entities so authorized by the Government and the whole process of export will have to be completed latest by 30th April, 2019.

2. In continuation of the orders in the reference 2nd read above, Government after careful examination of the proposals received in the reference 3rd read above from the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, hereby constitute a Committee with the following officers as members to work out the modalities for conducting sale of Red Sanders Wood for a quantity of 1083 MTs in log form in Phase-XI through Global e-Tender cum e-Auction:-

3. The Committee shall perform the following functions:-

- (i) To review the status of Red Sanders marketing in the light of the past experience and chalk out a strategy for sustainable marketing of Red Sanders for the present and the future.
- (ii) To decide the mode of disposal / type of auction.
- (iii) To identify appropriate agency through which the sale is to be conducted.
- (iv) To formulate Terms and Conditions for conduct of sale including the draft terms of reference (TOR) document.

- (v) To finalize draft tender document with all the relevant stipulations such as quantity, time for payment of EMD, Security Deposit, and for payment of sale consideration etc. other issues such as time limit for lifting material, payment of ground rent and penalties etc., for defaulters and all other relevant issues are also to be finalized.
- (vi) To determine unit of sale, i.e., quantity for each unit or lot-wise sales; and
- (vii) All other relevant conditions.
4. The committee shall finalize its recommendations immediately and submit the same to Government.
5. The Andhra Pradesh Forest Development Corporation Limited shall provide management services to Government of Andhra Pradesh for sale of Red Sanders, collection of sale amount and remittance of net revenue to Government duly deducting the expenses incurred in connection with sale of RS Wood and also appointed as an entity to export RS Wood to other countries on behalf of Government of Andhra Pradesh to the foreign buyers and also to facilitate the domestic buyers in export of Red Sanders Wood purchased by them on their IEC. The Andhra Pradesh Forest Development Corporation Limited is also permitted to charge administrative expenditure to the extent of 2% of the sale proceeds, subject to the limit of Rs.5.00 Crores plus Goods & Service tax for the sale.
6. Authorization is given to the Andhra Pradesh Forest Development Corporation Limited to engage the services of M/s MSTC Ltd. for conducting the sale of Red Sanders Wood through global e-tender cum e-auction on the terms and conditions approved by the Government in ITE & C (e-procurement) Department vide G.O.Rt.No.47, Dated.5-7-2017 or as the revised terms by the Government or at the present rate of commission payable whichever is low.
7. The Principal Chief Conservator of Forests and Head of Forest Force, Andhra Pradesh and the Vice Chairman & Managing Director, Andhra Pradesh Forest Development Corporation Ltd., shall inform from time to time to Government the Phase of Sale and the quantity involved in the sale and the results of the sale duly following the procedure indicated.
