SHOW CASE NOTICE
[To whom so ever it may concern]

It is to inform that, the forest officials under the jurisdictions of Sub-Divisional Forest Office, Tirupati of Tirupati (T) Division, Tirupati has seized the following 62 Nos vehicles while they were being used in illicit transportation of Red Sanders wood without any valid permit and without any Government transit marks.
